**Rural Health Enterprise CEO interviews:**

We have completed the first two rounds of CEO interviews for the Rural Health Enterprise (the for-profit arm of The Rural Collaborative). We have advanced two exceptionally strong candidates to the final round, which we anticipate will be in April.

**Olympia Orthopedic Associates Professional Service Agreement (PSA):**

We propose increasing the PSA for Orthopedic Call Coverage to \$1,500 per 24-hour periodic effective April 1, 2023. We anticipate this will increase call coverage to 50% for an annualized cost of \$273,750, which is within the 2023 budgeted amount.
