CNO

Kris Gaa did a fabulous job presenting on TeamBirth at the Rural Health conference the week of March 24th. TeamBirth is a joint effort between WSHA, Ariadne labs, and several Washington hospitals. We are in the third co-hort. TeamBirth is an industry-standard process to improve communication, teamwork, and shared decision-making throughout the birthing process, giving every person a chance at a safe, dignified childbirth experience. If you would like to hear more about TeamBirth, please let me know and we can facilitate a presentation.

I am pleased to announce that we have hired an Assistant Chief Nursing Officer. The position was formerly entitled Director of Acute Care Services held by Rob Bennington. The ACNO will directly oversee MSP, ICU, and House supervisors. Included in the reporting structure are two supervisors who assist with MSP and ICU, two of the largest nursing departments. Vinita Singh comes to us from Valley Medical Center where she worked as an ICU nurse and progressive leadership positions since 2006. Vinita was looking for a rural leadership position so she can connect with a strong community, and she feels Mason is the perfect fit.

The Mobile Integrated Health program went live on March 31st. This program has been running in North Mason for a little over a year with great success. EMS is leading this program with Chief Beau Bakken leading the program design and implementation. The coverage area is South Mason from Arcadia south past the Kamilche area. The program entails a provider (Behavioral Health nurse practitioner, Physician's Assistant, or wound care nurse) who is dispatched to the patient's home for services. The psych ARNP is able to direct admit to appropriate facilities for inpatient treatment, the PA can prescribe medications and diagnose, the nurse can perform wound care, etc. Currently, the ED, transitional care providers, and our discharge planning team are referring patients who meet certain criteria to the MIHP staff. We hope to prevent readmissions and unnecessary visits to the ED, WIC, and PCP's.

Open Positions: NAC'S: 0.9 ED nights, (2) 0.9 MSP day and night shift. Resource NAC: (2) 0.6 nightshift. RN'S: (2) 0.6 nightshift ICU, 0.6 Evening ED, 0.6 days ED, 0.8 Surgical.

Total NAC- 3.9 FTE's; Total RN FTE's= 3.2
