COO

Family Nurse Practitioner, Catherine Shutty has accepted an offer to join Mason Health in August. Catherine lives in Union and had precepted with Sara Holt-Knox at the Hoodsport Clinic in 2020. Ironically, we are talking with both Catherine and Dr. Burris about splitting Catherine's time between Hoodsport and Mason Clinic. Catherine is currently working at the Peninsula Family Medical Center in Gig Harbor and wants to get closer to her roots and community to provide care closer to home. She came highly recommended by Sara.

Providing an update on the Open Position Report reveals there are 53 vacant positions, representing 31.7 FTE; 18 of which are PRN. Seventeen of these positions have been vacant less than 30 days. These numbers seem consistent over the past several months, and much better than what we were experiencing at the time we determined this needed attention.

Budget Amendment

This budget amendment request is to upgrade a position in the HIM department, as part of a reorganization, that consolidates positions and improves performance, in order to have back-up and cross training for all areas. HR was consulted to develop the job description and pricing, including union considerations.

Our Level IV trauma application was submitted to the state and approved.

We will reach out to the RN union in July seeking dates for negotiations. Mike Brunet will be our lead council.

Covid levels have remained low. We have on average 1 employee out/week and we've had no admissions in about a month.
